



## **Giving Hearts Day Sweepstakes**

### **Official Rules**

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE THE CHANCES OF WINNING. ONE ENTRY PER PERSON PER FORM OF ENTRY IS ALLOWED. ELIGIBLE PARTICIPANTS MUST BE 18 OR OLDER AT THE TIME OF ENTRY AND MUST BE LEGAL PERMANENT RESIDENTS OF MINNESOTA OR NORTH DAKOTA. SWEEPSTAKES WINNERS ARE RESPONSIBLE FOR ALL APPLICABLE TAXES, LICENSES, INSURANCE, AND TITLES APPLICABLE TO THEIR PRIZES. SWEEPSTAKES ARE SUBJECT TO ALL APPLICABLE FEDERAL, STATE, AND LOCAL LAWS. ### **Eligibility**

This drawing is offered by Dakota Medical Foundation. There is no purchase, entry fee or payment necessary to enter, win, or obtain information about the sweepstakes. This sweepstakes is open to legal residents of North Dakota and Minnesota who are eighteen (18) years or older at the time of entry. Void where prohibited by law. Sweepstakes are subject to all applicable federal, state, and local laws. All employees and board members of Impact Foundation and Dakota Medical Foundation, along with those in their households, are ineligible to win any Sweepstakes prizes.

### **Timing/Sweepstakes Period**

The sweepstakes starts February 13, 2025, at 12:00 a.m. (CST) and ends February 13, 2025, at 5:00 p.m. (CST).

### **Conduct, Odds, Notification**

The odds of winning a prize depend on the number of eligible entries received. Thirty-four prizes will be given away, and the estimated chance of winning each prize is 1:60,000.

If the winner is not an eligible (or responsive) recipient, the prize will be given to another randomly drawn entrant until eligible recipients have been awarded all the prizes. The names of all eligible entries will be in a hat and the winners will be randomly drawn by Live Like Rach members and/or DMF personnel.

Each winner will be notified by telephone, email address, or through social media, depending on the information provided with the donation. Any winner notification returned as undeliverable without a forwarding address will result in sweepstake forfeiture and an alternative winner may be selected.

## How to Enter

These are methods of entry for the Live Like Rach Sweepstakes.

**Make a Donation on or before Giving Hearts Day 2025** - Make a Giving Hearts Day donation by credit card at <https://app.givingheartsday.org/#/charity/1088>, or by dropping a check off at DMF on or before Giving Hearts Day. Checks may be dropped off on February 13th between 12:00 a.m. and 7:00 p.m.(CST). For Giving Hearts Day, Donors who want to remain anonymous will automatically be opted out of the sweepstakes and can enter via another entry method, including the non-purchase method of entry.

### **Volunteer Pledge:**

**Pledge to Volunteer with a Giving Hearts Day Charity** - During the Giving Hearts Day Sweepstakes period, visit <https://app.givingheartsday.org/#/charity/1088> and pledge to volunteer by signing up to volunteer. Multiple pledges will result in a single sweepstakes entry. Pledges must be posted by 11:59 p.m. (CST) on February 13, 2025, or between 12:00 a.m. and 7 p.m. (CST) on February 13, 2025, to be eligible.

## Prizes
